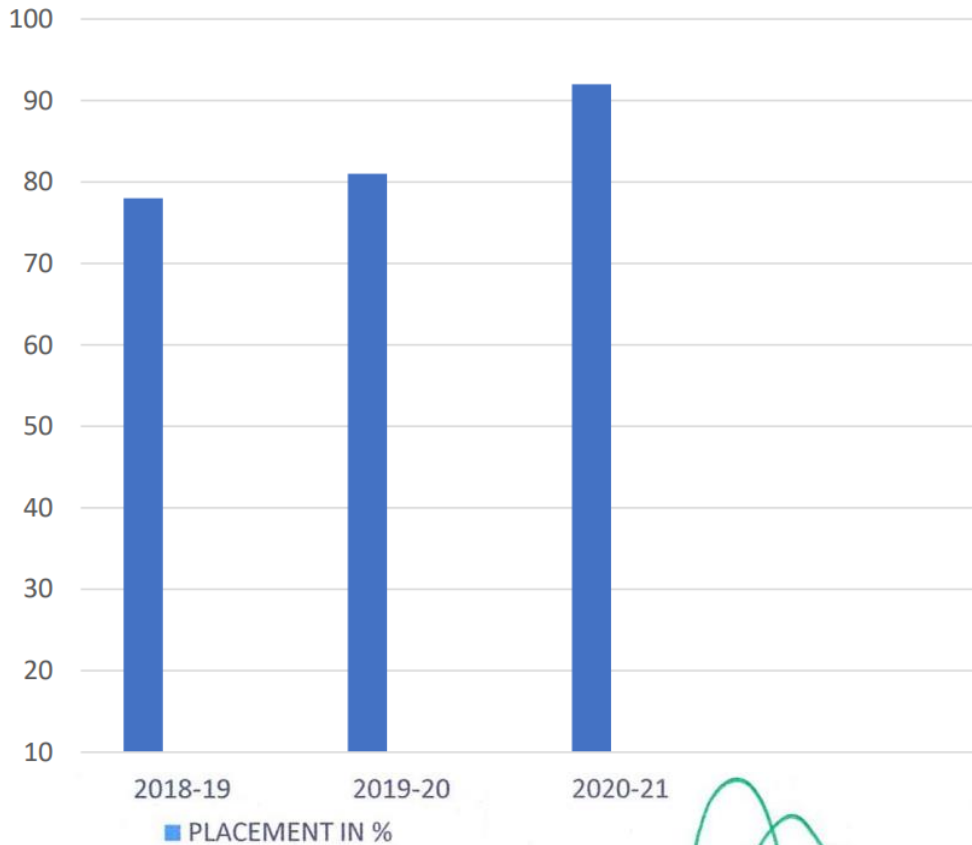




## PLACEMENT STATISTICS YEARWISE CHART


